Course Requirements

Enrolment Appointment

- Phone and book your enrolment appointment with a member of our training staff on (08) 9439 1673.
- Provide Photo ID (Driver's License or Passport)
- Provide Proof of Residency / Citizenship (Birth Certificate / Passport).
- Be reasonably fit and physically capable of performing the role.
- Meet the foundation skills (literacy and numeracy levels) necessary to perform in the role.
- Be able to attend and complete the training room and practical components of the course.
- Be eligible to participate in training in Australia.

Enrolment Pre-requisites

Enrolment into CHC43121 Certificate IV in Disability Support requires::

- Completion of CHC33021 Certificate III in Individual Support (Disability); or
- Completion of CHC33015 Certificate III in Individual Support (Disability); or
- OR CHC30408 Completion of Certificate III in Disability PLUS CHCSS00125 Entry to Certificate IV in Disability skill set.

*Eligibility Criteria

To be eligible for FREE training, you must have left school, have your primary place of residence in Western Australia and you are either:

- an Australian citizen; or
- a permanent visa holder; or
- a holder of a subclass 300, 309, 444, 445, 461, 785, 786, 790, or 820 visa; or
- a secondary holder of a temporary visa of subclass 188, 457, 482, 489, 491 or 494 visa; or
- a holder of a Bridging Visa E (subclasses 050 and 051) where the visa holder has made a valid application for a visa of subclass 785 or 790; or
- Ukraine citizens who are holders of a visa subclass 449 or 786;
- Afghan citizens who are holders of a visa subclass 499; or
- a holder of a bridging visa who are eligible to work, and who have made a valid application for a subclass 866.
